


The business of the Airpark continues to run along smoothly. Everything is working (including that pesky fuel pump). Although the bank account balance appears low right now, we have steady revenue and relatively low risk of any major expense surprise. Our major expense, which occurs periodically, is pavement maintenance. We voted to raise the fuel price by 50 cents per gallon and raise the discount 25 cents. This change puts the revenue flow more closely aligned with the projected pavement repairs.

A big thanks goes out to Jean Thompson for tracking the turbine traffic, which seems to have picked up recently. Letters were sent to those not paying landing fees. Most have responded and are cooperating and contributing. I also want to thank those doing ramp checks. This is an important monitoring tool to assess traffic, as well as identifying those few that do not seem to know or follow the operating rules.
